Presentation: Improve Your Death Literacy Speaker: Angela Mennitto



Angela Mennitto is a death midwife who works to organize community education events to promote death literacy—the practical know-how needed to plan well for the end of life—and to help normalize conversations about death and dying. She has been hosting a Death Café in Ithaca since 2013. She is passionate about any activity that helps normalize conversations about death and dying in our culture, anything that helps us "bring death out of silence."

Angela will talk about a variety of areas where planning now can help you, and your loved ones, at the end of your life. She'll talk about everything from advance care directives to aesthetic/environmental choices at the end of life to the importance of recording your digital details, and planning for pets. Finally, she will also talk about how planning funeral arrangements can save money, ensure you have what you want, and save your family from stressful decisions at a difficult time.

FTC Sends Warning Letters to Funeral Businesses Following Undercover Investigation by Deb Harper

Throughout 2023, investigators from the FTC and the Bureau of Consumer Protection Division of Marketing Practices made undercover phone calls to more than 250 funeral businesses across the country to get price information required by the Funeral Rule (1984). Investigators found 38 funeral businesses violated the rule by refusing to answer questions about pricing or by providing inconsistent pricing for identical services. One funeral business misrepresented the local health code by telling the caller that embalming was required (it was not). One funeral business promised to send the General Price list but instead sent a list of prices that did not meet Funeral Law requirements.

Warning letters restate the requirements of the Funeral Rule and ask the businesses to take prompt remedial action. Failure to comply can result in penalties of up to \$51,744 per violation. The National Funeral Directors Association (NFDA) provides a virtual remedial program where violators who pay for and complete a virtual remedial program can avoid fines and public disclosure of their names. In addition, funeral businesses pay 0.8% of their average annual sales in lieu of a civil penalty to the federal or state governments.

Funeral consumer advocates say it is inappropriate for the industry to police itself, and

critics of the Funeral Rule claim it does little to protect consumers as only a handful of the country's more than 20,000 funeral businesses have been inspected for compliance.

Document your concerns including the contact person you've been dealing with.
